

YEALAND REDMAYNE PARISH COUNCIL

Minutes of the Meeting of Yealand Redmayne Parish Council, held in the Village Hall, on Monday 15 July 2019 at 7.15 pm.

2881	TO ACCEPT APOLOGIES : Cllr L Marshall (work commitments) and Cllr Macklin (holiday) sent their apologies. The Clerk confirmed the meeting was quorate. (Min requirement three Councillors present).
2882	TO CONFIRM MINUTES OF PREVIOUS MEETING & SIGN THEM. The minutes were confirmed as a true record and signed by Cllr D Smith.
2883	<p>TO ADJOURN FOR PUBLIC PARTICIPATION : Cllr Williamson reported that Js 34- J35 of the M6 would be undergoing repair works, likely in late September. The traffic (including many large lorries) will need to be diverted via Kellett Road and over the bridge. This will have an impact on the smaller roads, but Cllr Williamson has managed to secure confirmation that the Highways Dept will fund the repairs necessary. Thanks were given to her for a successful outcome.</p> <p>The sign at the junction of the A6 and 8/19Acre Lane is to be moved to a better site. The A6 has now been repainted with safety lines etc and is much improved.</p> <p>City Cllr Greenwell reported life had been busy since she had been voted in, but is settling down now. She reported that City Council services were much reduced, due to lack of funds; Mobile signals were good in YR, but poor in Silverdale.</p> <p>Cllr Hancock reported that they have a new lengthsman, with a specific job/hour schedule. There may be scope for YR PC to use him too, if needed. YC PC wish to be consulted on matters that may require them to make a contribution (SPiD, Canal Work, De Fibs), before spending took place, to ensure they have enough in the Precept. (This needs to be looked at properly when setting next year's budget.)</p> <p>Cllr Smith reported that the light outside 8&9 The Meadows was on all day, the Clerk will report that to County.</p> <p>Cllr Harbison reported that the Triangle Bus Shelter had a broken windowpane and the Silverdale Rd Shelter needs keys to unlock the Notice Board The Clerk is dealing with these matters and will report back the costs of replacing the new pane.</p>

2888	<p>TO CONSIDER THE ANNUAL PLAY INSPECTION REPORT AND ARRANGE FOR REMEDIAL ACTION : The Clerk has not yet received the June Inspection Report. The rubber bush at the top of the smaller swings has split, Cllr Harbison has taped it up, but it should come under the £100 repairs allowed by City Council. The Clerk will chase that up. No-one else has reported the trampoline being problematical. Cllr Harbison confirmed he regularly checks The Meadows Play Area for H&S purposes.</p>														
2889	<p>TO CONSIDER WHITE LIGHTS FOR THE VILLAGE & APPROVED ELECTRICAL SOCKET FOR CHRISTMAS LIGHTS : UPDATE : The Clerk has received information</p>														

	<p>from both City & County Councils : The pillar can go onto the land by the hedge, which is City's land, so no licence is needed. An amendment to the existing lease agreement will be needed, to request the PC will maintain the pillar with an annual inspection, before lights will be used.</p> <p>City Council have agreed in principle that the unmetered connection can be used for the pillar and they will absorb the cost of the Xmas lights.; the Clerk has asked for costings of installing the pillar. Once these are known the project can go forward.</p>
2890	<p>TO CONSIDER CANAL IMPROVEMENTS : TOWPATH & LITTER PICK : The date set is Friday 19th July, Various Volunteers along with C&RT folk will be laying scalplings to improve the towpath. There have been problems trying to get in touch with the landowner of the field, to where the scalplings are being delivered. Still to be confirmed Payment will be made once the work is completed.</p>
2891	<p>TO CONSIDER VILLAGE JOBS : The Triangle Notice Board needs to be re-oiled, the Play Area fence ditto; the railings at Storrs need to be re-repainted. The Bus Shelters and Yealand Redmayne Sign also need a good wash. The Clerk will ask Community Payback Team if they can assist. The AONB should be able to tidy the Pound, the Pond Area at the Back of the village and they are due to do the Annual Check on the trees at Storrs Watering Place. The War Memorial Tidy is usually done later in the year.</p>

Clerk's Report for Meeting 15 July 2019

The Green Bin for the Meadows has now been delivered to 1 The Meadows. It has a collection sticker on it, the £40 due was paid on Clerk's M&S Card and is reclaimed in the Fee Note, thanks. The last collection is November .

Canal Towpath laying : Adverts went out and I have managed to get some homeless folk along to assist. Payment to be made at meeting, once final helper numbers known, delivery dependent on what can be laid by the few !

Xmas lights : Convolved process, but it seems City are OK to add the minimal electric charge to their unmetered bill and arrange for an agreement to allow the

PC to have the lights without any licence, as the tree is on their land at The Meadows, provided PC undertake to have the electric point maintained each year. This will need to be done as an annual inspection by a qualified electrician, say end November. I will put a note in the diary. I am still awaiting the cost of installing a pillar, to run electric from, from County.

Is the trampoline still OK ? The next quarterly inspection is due this month.

Annual (Nil) Return for Public Watering Place is due, I have completed it, it just needs resolving at meeting so I can submit, thanks.

Mansergh Trust : I am somewhat concerned that I am shown as a Trustee (by virtue of being YR PC Clerk). I have arranged for a meeting with Shaun at Ratcliffe and Bibby, who administer the Trust, to ensure that I do the job properly, what implications there are, etc.

Accounts OK, but LALC have not processed the cheque I posted out to them in May (as last year !) and neither has the Public Rights of Way Scheme money been received. I am chasing both up.

Are there any jobs in the village that need to be organised ? As Summer approaches, perhaps railing painting could be done as needed. Should I ask Community Payback / homeless, or would you prefer the residents to do it ?

Josh cutting Meadows OK and agreed to cut The Meadows hedge, will be paid at the meeting.
